TRAINING FUNDS POLICY
(Adopted by the Executive Committee on 3-15-2023)

1. Background and Purpose

In 2022, ECC and China Evangelical Seminary Society (CESS) established a partnership for CESS to provide Mandarin-speaking seminary training for ECC members and Christian leaders in the Metropolitan Seattle area. CESS is a renowned evangelical seminary school in Taiwan, which also established a branch campus in Vancouver, B.C., Canada. CESS in Vancouver provides both in-person and remote seminary courses taught by well-qualified Bible scholars and professors.

The seminary training program provided by CESS ranges from class auditing, online extension courses, and degree programs. To encourage church members to participate in seminary training for the betterment of Christian education at ECC, a training budget was established in 2023 to fund non-degree seminary training at CESS. Applications to other seminary schools and/or degree programs shall continue to follow the regular CE Scholarship Policy.

2. Eligibility of Applicants

- a. Must be eighteen (18) years old or older
- b. Must be an active ECC member
- c. Must exhibit Christian character and maturity

3. Limitation of Training Funds

The church may fund up to a maximum of four courses per calendar year for each approved applicant. The total amount of the training funds is limited to the budget available for the current year. Upon completion of courses in the current year, the applicant may apply for the following year with proof of satisfactory passing grades.

4. Application Procedure

An applicant must submit a completed CESS admission application and an ECC-CESS Training Fund Application Form to the Christian Education deacon/deaconess of his/her respective congregation (names of whom can be found at <https://eccseattle.org/en/meet-our-deacons-deaconesses/>).

5. Review Process

The forms will be reviewed and approved by a committee of three Mandarin pastors and a Christian Education deacon/deaconess from each of the three ECC Mandarin Congregations. Once approved, the applicant may then apply for admission to CESS directly.

6. Tuition Payment

Upon application approval, tuition can either be paid by ECC directly to CESS, or be paid by the applicant and reimbursed by ECC.

7. Amendments

Changes, modifications, or additions to this policy may be made by the Executive Committee.
